GAO Releases Report on Quality of Care Available for Patients with Limb Loss and Limb Difference

The Government Accountability Office (GAO) released a report focusing on the quality of care currently available for patients with limb loss and limb difference. This report, *Limb Loss: Rehabilitation Services and Outcomes for Medicare Beneficiaries*, was requested by a bipartisan group of senior members of Congress interested in disability policy, and it is expected that it will inform policymakers as they craft legislation to improve the quality of care available to this patient population. Marlis Gonzalez-Fernandez, MD, FAAPMR and Prateek Grover, MD, FAAPMR met with the GAO team that produced this report and provided PM&R's perspective as this report was drafted. Moving forward, your Academy will use this report to engage with federal health policymakers to improve the quality of care available for patients and to ensure that PM&R is represented on this important issue. Urge Your Congressional Representatives to Co-sponsor Legislation to Fix the Medicare Physician Payment System

A bipartisan coalition of U.S. Representatives has introduced legislation that would provide immediate payment relief to physicians and ensure continued access to care for PM&R patients. The *Medicare Patient Access and Practice Stabilization Act of 2024*, led by Representatives Marianette Greg Murphy, MD (R-North Carolina) and Jimmy Panetta (D-California), would stop the latest round of scheduled payment cuts and provide physicians with a 12-month payment increase equal to one half of the Medicare Economic Index (MEI).

If Congress does not act before the end of this year, physicians will face a cut of approximately 2.8% in 2025, which would be the fifth consecutive year that physician pay under the Medicare program has been cut.

Please take two minutes today to advocate for your specialty and your patients by contacting your representatives in the U.S. Congress and urging them to co-sponsor this important Academy-endorsed legislation to stop the looming Medicare payment cut.
